PMEGP Loan Interest Rate: The interest rate applicable as per bank’s norm for MSME enterprises is in the range of 11% and 12% pa. However, under the provisions of ISEC (Interest Subsidy Eligibility Certification) Scheme, the applicable interest rate is a concessional 4% for a mix of Working and Fixed Capital expenses.

PMEGP so far. Since its launch in 2008, the PMEGP scheme was receiving an average of 35,000 applications per year. The number of projects under PMEGP has increased from 52,912 in 2016-17 to 73,427 projects established in 2018-19. The amount of subsidy during this period has also gone up from Rs 1281 crore in 2016-17 to Rs 2070 crore in 2018-19.
